# **Role Summary and Accountabilities:**

The primary role of a BF Adventure Skills for Life Instructor is to support children and young people to develop their personal and social skills through engagement in outdoor activities. This activity is delivered through one to one support or small group work. Skills for Life Instructors have a demonstrable passion for the outdoors and the opportunities for learning that this provides children and young people. The role offers Instructors the opportunity to develop their own skill base and a commitment to this personal development is essential.

Instructors are at the front line of recognising safeguarding concerns presented by the service users and must follow BF Adventure's Safeguarding Policy and Procedures.

Instructors are accountable to the Education Programme Coordinators and are required to engage in BF Adventure's supervision and appraisal process.
