#### **Job Description**

### **Role Summary and Accountabilities:**

The primary role of a BF Adventure Skills for Life Instructor is to support children and young people to develop their personal and social skills through engagement in outdoor activities. This activity is delivered through one to one support or small group work. Instructors are responsible for planning and delivering the service in line with the specific needs of the individual or group, clearly identifying achievable outcomes with the young person, and for the continuous evaluation of the provision to meet further identified needs. Instructors are responsible for the monitoring, evaluation and recording of the individuals' progressions against these outcomes through the reporting tool.

Instructors are at the front line of recognising safeguarding concerns presented by the service users and must follow BF Adventure's Safeguarding Policy and Procedures.

Instructors are required to engage in formal supervision with the Education Programme Manager and in BF Adventure's appraisal process. Effective participation in Skills for Life team meetings is essential to further enhance the provision that BF Adventure offers.

Skills for Life Instructors have a demonstrable passion for the outdoors and the opportunities for learning that this offers children and young people. The role offers Instructors the opportunity to develop their own skill base and a commitment to this personal development is essential.

#### **Responsibilities:**

- Understand how outdoor learning can be used to develop individuals' capacity
- Facilitate creative interventions with a range of service users and encourage reflective thinking
- Identify the needs of service users in liaison with the Education Programme Manager and with reference to referral information
- Effective planning of sessions and resources required to ensure effective programmes that meet the specified needs
- Understand patterns of behaviour by service users and the ability to respond appropriately in line with youth work values
